## What's Happening With The Control House

INC Staff will attend the Association of Community Mental Health Authorities (ACMHAI) membership meetings virtually on August 10 & 11, providing an opportunity to collaborate with fellow colleagues in the industry.

In FY24, 17 agencies and 36 programs are funded with the goal of moving our mission forward. There are 3 new agencies and 5 new programs that address present and future needs of residents within the 7 townships that INC serves. The 3 new agencies fill a gap in providing needed services to young children and the IDD community. Four of the 5 new programs are in response to the funding opportunities that our board provided utilizing the building sale proceeds. These opportunities focus on youth peer leaders and calming rooms in local schools, addressing the workforce shortage through paid internships, and the DSP shortage through a certification partnership with our local community college.

INC is preparing to work with an Outcome Evaluator as a service to our funded agencies who want to improve their Outcome Reporting process. The Evaluator would review the reporting process and frequency of reporting with the agencies and with INC staff. The goal is to create a report that provides measurable data so that our board of directors, and other potential funders, can understand and appreciate the impact of the agency's programs.

#### Thank you to our Board Members



Did you know that 988 Suicide & Crisis Lifeline is an effective, life-saving safety net for those experiencing suicidal ideations or a mental health crisis? The Lifeline is made up of a network of local and state-funded crisis centers across the United States. The counselors at local crisis centers, such as INC-funded agency Suicide Prevention Services, answer calls and chats from people in distress that Lifeline receives every day. However, most recent survey results indicate that only 18% of adults in the U.S. have heard of the Lifeline and its purpose since it was launched in July 2022. (<a href="www.pewtrusts.org">www.pewtrusts.org</a>) While this data is concerning, there are a few ways to increase awareness of this life-

saving tool. Donating to your local crisis center, advocating for 988 based on your personal experience with them, or sharing about their services on social media are effective methods to increasing awareness and support of 988.
