## Outpatient Behavioral Health



Ascension is one of the nation's leading non-profit and Catholic healthcare systems, with a Mission of delivering compassionate, personalized care to all with special attention to persons living in poverty and those most vulnerable. The Outpatient Behavioral Health has several locations, including the Mercy Hospital campus in Aurora. The clinic located in Aurora provides outpatient mental health counseling for individuals, couples, family, and group therapy, beginning at age 6 and throughout the life span. The clinic provides adult and adolescent psychiatric services, including psychiatric evaluations and medication management. Also included is a 24-hour crisis hotline (1-708-681-4357) that assists with intervention and psychiatric pre-screenings. Services specialize in Depression, Anxiety, Bipolar Disorder, and Severe Mental Illness. Individuals may schedule an appointment in English or Spanish at the Central Access Intake Line at 708-410-0615. 

### October is Substance Use Awareness Month




There are 20 million individuals in the USA who are struggling with a substance use disorder. Nine out of ten people with a substance use disorder start before the age of 18. With these staggering facts, intervention and prevention are critical protective factors that could reduce and even prevent substance use. In accordance with its mission, INC Mental Health Alliance funds several programs that serve

those struggling with a substance use disorder and their loved ones:

- Gateway Foundation offers a wide variety of help in a clinical setting to aid individuals in their path to recovery. Residential Services offer 24/7 support and medical care for substance use. Visit their website at <u>www.gatewayfoundation.org</u>.
- Conley Outreach Community Services is involved in the Kaneland Community Partners Healthy Youth program. It is a coalition of like-minded individuals and organizations dedicated to reducing and preventing substance use by youth through innovative educational and relational approaches. - Mutual Ground's Substance Use program offers an individualized treatment approach to help people overcome their substance use and work through the trauma that may be associated with it. Services include adult and adolescent outpatient services, co-occurring disorder program, intensive outpatient program, DUI counseling, recovery support groups, case management, medication assistance treatment, and

Did you know that 1 in 3 women and 1 in 7 men will be abused by an intimate partner in their lifetime? In the state of Illinois, there are more than 41,000 survivors of domestic violence and more than 8,000 child witnesses. In a one-year period, domestic violence incidents have led to 61 deaths in the state of Illinois. Domestic Violence Awareness month takes place every October to educate the community and stand in support of the victims and survivors.

INC-funded agency Mutual Ground provides services 24 hours per day, 365 days per year to support the needs of victims of domestic violence, sexual assault, and abuse.
